S. R. O. No. 316/2018.—In exercise of the powers conferred by section 21 of the Code of Criminal Procedure, 1973 (Central Act 2 of 1974), the Government of Kerala hereby appoint the Sectoral Officers, as appointed by the District Collector, Alappuzha vide Proceedings No. M1/4823/18(4) dated 28th April, 2018, specified below as Executive Magistrates to be known as Special Executive Magistrates within the jurisdiction limit as noted in the said proceedings, limited to the ensuing Bye Election to the 110-Chengannur Legislative Assembly Constituency from the date of the notification of bye election to the date on which the election process will be completed and confer on them all the powers that are conferrable under the said Code on Executive Magistrates.
