ORDER

The poll in connection with the Bye-election to 01-Manjeshwar, 82-Ernakulam, 102-Aroor, 114-Konni, 133-Vattiyoorkavu Legislative Assembly Constituencies will be held on 21st October 2019 (Monday). Hence Government are pleased to declare the day of Poll i.e. 21st October 2019 (Monday) as public holiday for all Public Offices and Educational Institutions and a paid holiday for all Government/Quasi Government and Commercial Establishments under Negotiable Instruments Act 1881 for the area covered by 01-Manjeshwar, 82-Ernakulam, 102-Aroor, 114-Konni, 133-Vattiyoorkavu Legislative Assembly Constituencies.

In addition to the above, Government are pleased to declare the following:-

The Labour Commissioner will make necessary arrangements with all Private Enterprises, Private Industrial centres and other Private Institutions under the shops and Commercial Establishment Act, and located on the aforesaid areas, to declare the day of poll viz. The 21st October 2019 (Monday) as a paid holiday for all their employees. No deduction or abatement of the wages of any such persons shall be made on account of a holiday having been granted in accordance with law and if such person is employed on the basis that he would not accordingly receive wages for such a day, he shall nonethless be paid for such day, the wages he would have drawn had not a holiday been granted to him on that day.

Employees including casual workers who are ordinarily resident of the above Constituency where poll is taking place, and registered as an elector, in these constituencies but serving/employed in an industrial undertaking or an establishment located outside the constituencies where he/she is resident have to be given the benefit of paid holiday on the day of poll.
