In compliance with the directive of the Election Commission of India and following a prior notice, a cross-inspection was conducted on April 11, 2024, of your election expenditure accounts up to April 9, 2024. This inspection was carried out alongside the Shadow Observation Register maintained by the Assistant Expenditure Observer (Headquarters) in the presence of the Expenditure Observer. The following discrepancies have been noticed, and you are directed to reply within 48 hours of receiving this notice

1. As per the Shadow Observation Register up to 09/04/2024, the total expenditure booked under expenditure on **Public Meeting of the Candidate** is Rs. 78805/-, however the amount booked in the Candidate's Election Expenditure Register under this head is Rs. Nil. There is an Understatement of Rs. 78805/- in the Candidate's Account.
2. 
