  - (b) Board with wooden frames is 28,938.5 @ Rs.30/sq.ft amounts to Rs.8,68,155/-V
  - (c) Cloth banner with wooden Board is 12,571@ Rs.30/sq.ft amounts to Rs.3,77,130/-
  - (d) Cloth flags is 1577 @ Rs.10/sq.ft amounts to Rs.15,770/-
  - (e) Construction of Election campaign office 230 @ Rs.20/sq.ft amounts to Rs.4,600
  - (f) Eco friendly flex/boher 4430 @ Rs.20/sq.ft amounts to Rs.88,600/- ▼

Expenses for vehicles based on permission may be added to the day to day accounts maintained by the candidate. The expenses incurred for vehicle announcement may also be added to the register.
- The expenditure for erecting boards with wooden frames in different parts of the constituency amounts to 19,65,195/- as per SOR. However, expenses in this regard as per the candidate register is 5,72,400/-. The under statement of expenditure may be accounted by the candidate.
- As per SOR, the expenditure incurred for wall writing is 1,45,369/- as on 13/04/2024. However
  the amount accounted by the candidate is 99,050/-
- Expenditure in relation to erection of cloth banners, as per SOR is 98,260/-. However the candidate has not accounted any expenditure for the item.

The expenditure for the above items may be incorporated in the accounts of the candidate.

Ref: Notice No. DCIDCK/1996/2024-F5 dated 15/04/2024 issued by your Office

As per your above referred notice, I am required to submit my explanation in respect of some discrepancies pointed out in the said notice.

I may submit my explanation in respect of each of the discrepancies pointed out as follows:

1. As per Discrepancy No.1, it is pointed that the expenses for vehicles based on permission is not seen added in the day to day account submitted by me as well as per the register. It is true that the expenses for vehicles based on permission are to be accounted. But the said expenses are being managed by the respective Assembly Mandalam Committees. All the said accounts are yet to be received and coordinated. It is in the said circumstances that only an amount of Rs.56,000/- alone was shown in the accounts already submitted. Once we receive the details regarding the said expense from the concerned Assembly Mandalam Committees, the same will be incorporated without fail. In this regard, we may also submit that the LDF Committee had taken a decision not to conduct any election propaganda during the auspicious days of Vishu and Eid al-Fitr. Apart

from the above, we have already taken a decision to cancel the permission obtained in respect of 21 numbers of vehicles and request for cancellation has already been submitted before the RO vide letter dated 17/04/2024.

2. In reply to Discrepancy No. 2, referred to in the above notice, we may be submit that the assessment made in the notice is not correct. In fact, the expense shown in this regard as per the Candidate Register is true and correct statement. In this regard, we may point out that as per the Assessment earlier made in the notice dated 14/04/2024, expense for the said item is shown at Rs.8,68,155/only. After the said date, we have not erected any new boards with wooden frames. It is true that the location/site of some such boards were changed so as to make the campaigning more effective. But as already submitted above, no new installations were made.

In this regard, we also want to submit that the rate fixed at Rs.30/per square feet with respect to board with wooden frames and cloth
banners is excessive and much above the actual cost prevailing in the
area. In fact, as we all know, the cost incurred in that regard in hilly
areas of the constituency is much lower than that of the urban areas.
This is because, in the hilly areas, the labour cost is much lower than
the urban area especially due to lesser cost of living and the
availability of larger labour force and raw materials. Even though, our
representative, during the meeting held for fixing the rates, had
pointed out the above unrealistic way of fixing the rate, this said
objections were ignored. It was in such circumstances that the above
exorbitant rate happened to be fixed. For the above reasons (1) the
mistake in the extent of square feet shown in the shadow register
and (2) the exorbitant rate, the said discrepancy noted as SI.No.2 in
your notice, above referred, may kindly be reviewed.

3. It is also submitted that a similar objection has been raised by our representative in the rate fixation meeting regarding the rate fixed for other items also. This is because a casual verification of the rates now fixed in comparison with the prevailing rates in the area would show that the rate fixed in the meeting is excessive and unrealistic. But the said objection also was rejected without a reason.

- Regarding Discrepancy No.3, we have shown only the accounts received from the LDF Assembly Committees so far, some more accounts are yet to be received and we will be accounting the same once the said details are received.
- Regarding Discrepancy No.4, it is submitted that as in the case of wall writing, the accounts are yet to be received from the LDF Assembly Committees so far, and once we receive the same, we will be accounting the same.
- 6. Apart from the above aspect, we may point out our grievances that as per our understanding, the total expenses as per the Shadow Register maintained for the UDF candidate, the total expenditure till today is said to be around Rs.12 to 15 Lakhs, whereas, expenditure noted as against the LDF candidate is around Rs.35 Lakhs. But an overall inspection in the constituency would show that the campaigning and propaganda being carried out by the UDF candidate is neck to neck with our candidate. In fact, we are not using normal hoardings, digital flex boards, which are being widely used at every important junction of the constituency by the UDF candidate. Further, vehicles fixed with digital flexes are also being used in the campaigning of the UDF candidate. But still, their expenses are shown to be that much lesser than my accounts and expenses. This aspect is also being pointed out for you kind notice.

Ref: Notice No. DCIDK/1996/2024-F5 dated 24.04.2024

With reference to the above we may submit the following explanations in respect of each of the discrepancies pointed out as follows:

- i. As per discrepancy No. 1, it is pointed out that expense for public meetings for an amount of Rs. 434565 is not accounted for in the Candidate's Register. Expenses in connection with public meetings are being managed by LDF Assembly Mandalam Committees concerned and we have taken steps to collect and co-ordinate the details from them. Once we receive the details regarding the said expenses from the LDF Assembly Mandalam Committees concerned, we will incorporate the same without fail.
- ii. As per discrepancy No. 2, it is pointed out that expense for public meetings with star campaigners are estimated for an amount of Rs. 634730 to be accounted. We have already accounted for some expenses and more details are yet to be received from LDF Assembly Mandalam Committees concerned. In this connection we may point out that star campaigners meeting expenses assessed by the SOR team is much higher than our actual expenses. We may inform you that the assessment made in the notice is not correct. Steps are being taken to collect the said expenses and the same will be accounted in the Candidate's Register without fail.

iii. Regarding discrepancy No. 3, we may submit that the assessment made in the notice is not correct. Assessment made as per the SOR is too high than that of the actual expense. In this regard we may invite your kind attention to the facts pointed out in our earlier explanation by us dated 17/04/2024. This Explanation may also be treated as a part and continuation of the previous explanation submitted on 17/04/2024. No new installation

of boards and hoardings were made after 17/04/2024. Some more details regarding the expenses are yet to be received from the respective Assembly Mandalam Committees

concerned. We will incorporate the same once it is received from the Assembly

Mandalam Committees concerned.

iv. As per discrepancy No. 4, we have been informed that the expenses for the vehicles for an amount of Rs.2344000 are to be accounted in the Candidate's Register. It is true that all the expenses for the vehicles based on the permission/passes are yet to be accounted. However it is added that the permission/passes taken for many of the vehicles were cancelled by us later. Further, all the expenses incurred related to the vehicles are yet to be received from the Assembly Mandalam Committee concerned and the same will be

incorporated in the register without fail, once it is received.
