## <u>ORDER</u>

The Booth Level Officers (BLOs) are entrusted with the responsibility of distribution of Voter Information Slip pertaining to election. They shall visit all the households in the polling station area concerned and distribute Voter Information Slip on proper acknowledgement. Since most of the BLOs are Government Employees, duty leave has to be sanctioned to them for those days they are engaged in the distribution of Voter Information Slip.

2. In the above circumstances, in connection with the Bye-Election to 56-Palakkad AC, 61-Chelakkara (SC) AC and 04-Wayanad PC, Government are pleased to order that duty leave will be sanctioned to Booth Level Officers of 56-Palakkad AC, 61-Chelakkara (SC) AC and 04-Wayanad PC, for 2 (Two) days within the period of 01.11.2024 to 08.11.2024, in which the BLOs can select any of two days to complete the distribution of Voter Information Slip to the electors of their respective polling stations.

3. All Heads of Departments shall sanction duty leave for the above purpose of those officers under their control, who are appointed as Booth Level Officers of Polling Stations in 56-Palakkad AC, 61-Chelakkara (SC) AC and 04-Wayanad PC on production of duty certificate duly authorized by the concerned Electoral Registration Officers.
