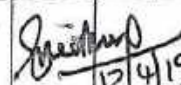

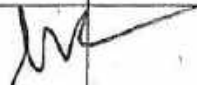
2nd reconciliation done on 17.4.2019. Minor discrepancies pointed out during 1st reconciliation rectified. During this reconciliation it has been found that:
