

If the candidate has not submitted his account for inspection in spite of notice by the RO. A permission given for the use of vehicle will be withdrawn.

 If the candidate after obtaining permission from the RO does not intend to use the compaig vehicle, for any period of more than two days, he/she shall intimate the RO to withdrawn th permission for such vehicle.

The permit issued should be kept with the driver and shown on demand.
