According to the notice there is a shortage of Rs.4,76,121/- in our expenses compared to the SOR account as on 14-04-2019.

The major difference came on the head of wall writings. Here we state that some more details regarding the wall writing from 4 of the assembly segments are yet to come. We expect that as soon as we receive the details from these assembly segments, these difference will be wiped out.

The other area of difference is boards and hoardings. The materials used for erecting hoardings are old materials and cost for the same was less much than the official rate of Rs 110/Sq Ft.

Thus the SOR assumed the official rate which has created big difference in this head of expenditure too. So we request the RO to consider our representation for a reduced rate for hoardings which we used old materials and voluntary labour.
